## GTL acquires Genesis Consultancy Ltd

GTL to capture 3G opportunities in India, APAC, USA and UK

*Mumbai* 17<sup>th</sup> October 2006- GTL, India's leading network services provider has acquired Genesis Consultancy Ltd, a leading network management services provider in the telecommunications industry in UK.

Under the terms of the agreement, which was approved by the companies' board of directors, the cumulative purchase consideration will be approximately USD 9 million **all in Cash for 100% buyout.** 

The acquisition of Genesis will strengthen GTL's Network Operations and Maintenance as well as the Professional Services component of their value chain. The Estimated Revenues and EBITDA of Genesis for FY 07 are US\$ 20 million and US\$ 2 million respectively.

Genesis has a strong resource base of 100 Engineers with the latest 3G technology skill sets. This acquisition gives GTL a foothold in the emerging global 3G markets with the first movers advantage in India and other emerging markets

Speaking on the acquisition, **Mr**. **Manoj Tirodkar, Chairman & MD, GTL Limited** said, "This acquisition presents the combined customer base a reliable migration path forward and global support for a comprehensive range of products and services in the Telecom industry. Genesis strategically fits well into GTL's value chain and has excellent domain knowledge and established customer base for existing products. With this acquisition, we expect the Network Management and Operations Business of the group to grow substantially and expect that this revenue stream will contribute 15 to 20% to our top line over a period of three to five years."



On the occasion, **Mr. David Edmondson, Managing Director, Genesis** said, "While Genesis is present and working on Network Engineering projects in Europe, USA and APAC, GTL is strong in South Asia, Middle East and growing in Africa. Both the organizations can therefore benefit through pushing their services in each others territories enabling us to exploit synergies with a global footprint".
